Joint Committee Report in Pursuant to Order dated 21.11.2022 passed by Hon'ble NGT (PB) in Original Application No. 838/2022 titled Prem Prakash Prajapati Vs. Project Director, PIU Sonipat & Ors.

1. Background

Hon'ble NGT vide order dated 21.11.2022 in O.A. No. 838/2022 titled as Prem Prakash Prajapati Vs. Project Director, PIU Sonipat & Ors. has issued following Directions:

"3. Having regard to above, we find it necessary to verify the factual position and to ensure remedial action in the matter.

4. For this purpose, we constitute a joint Committee of CPCB and Director, Environment Department, Delhi. CPCB will be the nodal agency for coordination and compliance. The Committee may hold its first meeting within two weeks from today. Except for site visit, it will be open to the Committee to meet online or off-line. The Committee will be at liberty to co-opt any other expert/institution and interact with any other concerned department or stakeholders. The Committee may ascertain the factual position and prepare an action plan for remedial action within one month. The compliance status as on 31.12.2022 may be communicated to this Tribunal by 15.01.2023 by e-mail at judicial-ngt@gov.in preferably in the form of searchable PDF/OCR Support PDF and not in the form of Image PDF. The said report may also be placed on the website of the CPCB with intimation by e-mail to the alleged violators for their response, if any, before the next date."

Copy of NGT Order under reference is enclosed as Annexure 1.

2. Follow-up Action on Compliance of Hon'ble NGT Order

2.1 Constitution of Joint Committee

2.2 Meetings of the Joint Committee

Preliminary Meeting of the Committee Members was held on 13.12.2022 through video conferencing. Minutes of the this Meeting are placed at **Annexure – 2**. Second Meeting of the Committee along with Applicant and Project Proponent was convened on 13.01.2023 through video conferencing. Minutes of the this Meeting are placed at **Annexure – 3**.

2.3 Communication with Applicant and Project Proponent

Applicant and Project Proponent (PP) vide Letters and E-mail dated 12.01.2023, were requested to attend the meeting scheduled on 13.01.2023 through Video Conferencing. M/s NHAH had also been requested to provide copies of the Approvals, Clearances, Consents, Permissions etc with regard to the Project under reference on or before 13.01.2023. Further, site inspection by the Joint Committee was conducted on 19.01.2023 wherein Applicant and PP were informed to be present at the site on 19.01.2023 along with all necessary documents and concerned staff.

2.4 Site inspection by the Joint Committee

The site under reference was visited by the Joint Committee along with Applicant and Members from Project proponent NHAH PIU Sonipat on 19.01.2023.

Overall Observations :

Grievance of the Applicant is in order with regard to following :

1. Govt of NCT vide notification dated 20.09.2017 has stated as follows:
 - a. Compensatory plantation of 19250 will be raised and maintained for 7 years and monitored till its successful establishment in 19.52 Ha land at Yamuna flood plain between Yamuna bank metro station and Railway land adjacent to CWG village complex as allotted by DDA.
 - b. Planatation along the edge of ROW ,wherever feasible , in addition to above, compensatory plantation will be done by User agency.

NHAI has not carried out plantations at the project site in spite of availability of land at many places. This is the gross violation of the condition stipulated in the Clearance issued.

2. Dust mitigation measures at the project site are not being taken . As a result, adjacent villagers are being exposed to dusts which could have been avoided.

4. Action plan for Remediation

In view of above observations, following action plan for remedial have been proposed by the Joint Committee:

- M/s NHA I should follow concerned Environmental Rules and Guidelines in letter and spirit. They shall abide by the provisions of the Environment (Protection) Act, 1986 and Rules and Amendments notified from time to time under the said Acts for control of air pollution and environmental safeguards.
- They must follow Environmental Management Plan and make display of the same without further delay at different interval of the stretch under reference.

However, with regard to dust mitigation and plantation, following specific action as proposed by the Committee may be referred:

4.1 For dust mitigation

They shall take all the necessary arrangements for dust mitigation measures at the time of construction and after construction of the corresponding stretch on priority. Following action points may be referred for the same:

4.1.1 Dust Pollution Mitigation Measures during Construction Phase

The measures which may be taken during the construction phase are as follows:

- Loose soil, sand and other construction material must be kept in earmarked area and shall be covered and road side storage of construction material and C&D waste generated if any should be prohibited.
- Construction material must be covered while they are transported.
- Kachha Roads must be paved and blacktopped on priority.
- Water sprinkling be carried out on the stretches where construction work is being carried out and while loading/unloading of construction materials are being done.
- Construction Machinery which generate dust should be kept away from lane on use and should not be in placed at upwind direction.
- If any C&D waste is generated, must be placed in earmarked area and may be further sent to waste processing facility.
- Construction machineries having inbuilt dust reduction measures may be used preferably.

- For compliance of Environmental Norms at the High Way, all measures must be taken and self-monitoring of the same must be carried out by M/s NHAI.
- M/s NHAI may also install display containing information regarding measures taken for dust mitigation along with the project details at different interval of the stretch under reference for public viewing.
- Adequate number of Anti-Smog Gun(s) should be installed with minimum horizontal throw of 30-50 m for mobile and of 70-100 m for stationery Anti- Smog Guns. Mandatorily installation at active construction/excavation/earth compaction area.

4.1.2 Air Pollution Mitigation Measures during Operation Phase

- For dust mitigation during operation phase sprinkling on the road at regular interval shall be carried out depending on weather conditions and Anti Smog Guns should be suitably deployed.
- Green belt with adequate no. of native plants along the stretches wherever feasible shall be developed.

4.2 For Plantation

- Scheduled plantation may be ensured by M/a NHAI in consultation with concerned Departments.
- Further, scope of plantation may be explored at following spaces:
 - a. Spaces opposite to Bageecha Resort (near Gurdwara)
 - b. From Vill. NaangliPuna towards Sonipat concreting may be avoided at the middle of the Lanes and plantation may be done.
 - c. Possibility of plantation between 8-lane and Service Road before Sani DhamMandir has been found.
 - d. Opposite side of Carnival Marriage Hall and Bharat Petroleum Pump along Sani Mandir Road possibility of plantation has been found.
- Encroachments of ROW have been found at various locations of the Stretch under reference and same may be removed in consultation with concerned Departments and possibility of plantation may be explored there.
- Local plants and bushes variety have been found in some locations and plantation of those and native plants are encouraged.
- Representatives of M/s NHAI are advised to explore the scope of plantation of shrubs, grasses etc. before and after tunnel construction.
- Plantation along the edge of ROW, wherever feasible must be done by the M/s NHAI.

4.3 For Air Quality Monitoring

- Periodic monitoring of air quality be carried out as per NAAQS, 2009 and submit reports to Delhi Pollution Control committee.
- Air Quality Monitoring of major parameters i.e. PM_{2.5}, PM₁₀, SO_x, NO_x must be carried out monthly basis during construction phase and half yearly basis during operation phases and report of the same must be sent to Delhi Pollution Control committee. The information derived from the monitoring can be used to mitigate and reduce the impact on air quality.

5. Joint Committee's Recommendations

Following recommendations have been made by the Joint Committee Members:

- M/s NHA I must comply with the conditions stipulated in the Forest Clearances / NOCs.
- M/s NHA I may follow above mentioned Action Plans from the time of availability of this report.
- M/s NHA I may also follow-up with the Forest Department, Government of Delhi and ensure scheduled plantation.

ORDER

1. Grievance in this application is against failure of the National Highways Authority of India (NHAI) in complying with its environmental obligations in the course of construction of 8-lane highway No. 44 from Mukarba chowk to Singhu border, Delhi.

2. It is stated that near Village Khampur lot of dust is generated in absence of sprinkling of water. Other hotspots are Palla-Mod, Singhola Mod, Vaishvan Dhaba to Village Khampur. It is further stated that 161 trees have been cut in January 2021. Though 1760 trees are claimed to have been planted, the same are at Garhi Mandu, near Yamuna Bank, 26 km away from Village Khampur which does not in any manner mitigate the dust generated by the project at the place where trees have been cut

and thus do not substitute the environmental services of the cut trees. Object of compensatory afforestation is to maintain balance of ecology at the location where trees are cut. This is not achieved if trees are planted at any far of location. It is further stated that about 100 four-wheelers, trucks and buses pass per minute on the highway. Each vehicle generates about 404 gm of CO₂ per mile (1.6 Km) mean being 252 gm of CO₂ per vehicle per kilometer. Total 250 vehicles passing per 5 minutes on one side emit $252 \times 500 = 126000$ gm = 126 Kg of CO₂ per 5 minutes. There is also non-compliance of Green Highway (Plantation, Transplantation, Beautification and Maintenance) Policy, 2015. Secretary, Environment and Forest, Delhi, has issued order for payment of compensation of Rs. 11,12,64,000/- in lieu of uprooting of 1952 trees but the NHAI has failed to make the said deposit.

3. Having regard to above, we find it necessary to verify the factual position and to ensure remedial action in the matter.

4. For this purpose, we constitute a joint Committee of CPCB and Director, Environment Department, Delhi. CPCB will be the nodal agency for coordination and compliance. The Committee may hold its first meeting within two weeks from today. Except for site visit, it will be open to the Committee to meet online or off-line. The Committee will be at liberty to co-opt any other expert/institution and interact with any other concerned department or stakeholders. The Committee may ascertain the factual position and prepare an action plan for remedial action within one month. The compliance status as on 31.12.2022 may be communicated to this Tribunal by 15.01.2023 by e-mail at judicial-ngt@gov.in preferably in the form of searchable PDF/OCR Support PDF and not in the form of Image PDF. The said report may also be placed on the website of the

1. The Joint committee offered the opportunity to the Applicant namely Shri Prem Prakash Prajapati to brief the grievances. It was informed to the Committee that necessary afforestation and plantation around the affected areas and 'Right of Way' are not undertaken by NHAI. Further, dust mitigation measures during construction phase are also not practiced by NHAI.
2. It was informed by Shri Hanumant Sangwan, Project Director, NHAI, Sonapat that that all the necessary approvals , Consents, Clearances and NOC have been obtained by them. It was also informed that NHAI has deposited the compensatory afforestation fund to Forest Department, GNCTD for plantation at alternative site provided by DDA.
3. Shri Satyendra Prasad, Range Officer, Forest Department, GNCTD informed that status of afforestation under reference shall be informed to the joint committee before the site inspection.
4. DPCC Officer Shri Surender Singh, AEE asked NHAI about the status of plantation, its locations and justification regarding location of compensatory afforestation.

After detailed discussion, it was decided by the Committee that:

1. NHAI will provide copies of all the Approvals , Consents, Clearances and NOC, and other relevant documents to the Joint Committee latest by 16.01.2023.

2. Applicant may provide other information/supporting document , if any and as available with him.
3. Shri Satyendra Prasad, Range Officer, Forest department will provide status of compensatory afforestation before the site inspection by the joint committee .
4. Joint committee will analyse the documents submitted by NHAI and Applicant and will conduct site inspection in the presence of Applicant and NHAI.



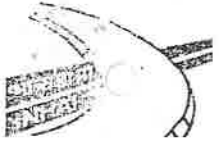



S.O. 2559(E).- Whereas by notification of the Government of India in the Ministry of Environment and Forests vide number S.O.1533(E), dated the 14th September, 2006 issued under sub-section (1) and clause (v) of sub-section (2) of section (3) of the Environment (Protection) Act, 1986 read with clause (d) of sub-rule (3) of rule 5 of the Environment (Protection) Rules, 1986, the Central Government directed that on and from the date of its publication, the required construction of new projects or activities or the expansion or modernization of existing projects or activities listed in the Schedule to the said notification entailing the capacity addition with change in process or technology and or product mix shall be undertaken in any part of India only after prior environmental clearance from the Central Government or as the case may be, by the State level Environment Impact Assessment Authority, duly constituted by the Central Government under sub-section (3) of section 3 of the said Act, in accordance with the procedure specified therein;

And whereas the Government of India in the Ministry of Environment and Forests had constituted a High Level Committee under the Chairmanship of Member (Environment and Forests and Science and Technology), Planning Commission, vide OM No.21-270/2008-IA.III dated the 11th December, 2012 to review the provisions of Environmental Impact Assessment Notification, 2006 relating to granting Environmental Clearances for Roads, Buildings and Special Economic Zone projects and provisions under the OM dated the 7th February, 2012 issued by the Ministry of Environment and Forests regarding guidelines for High Rise Buildings;

And whereas one of the terms of reference (ToR) of the Committee was to review the requirement of Environmental Clearance for highway expansion projects up to the right of way of 60 meters and length of 200 kms under Environmental Impact Assessment notification;

And whereas the Committee has submitted its report to the Ministry and on this ToR, the Committee has recommended exempting highway expansion projects from the requirement of scoping and that Environmental Impact Assessment or Environment Management Plan for highway expansion projects may be prepared on the basis of model ToRs to be posted on Ministry's website and in respect of requirement of environmental clearance, the Committee has recommended that expansion of National Highway projects up to 100 kms involving additional right of way or land acquisition up to 40 mts on existing alignments and 60 mts on re-alignments or by-passes may be exempted from the preview of the notification;

And whereas the report of the Committee has been examined in the Ministry of Environment and Forests. Earlier, vide notification S.O. 3067(E), dated the 1st December 2009 all State Highway expansion projects, except those in hilly terrain (above 1000 m AMSL) and ecologically sensitive areas, have already been exempted from the purview of the Environmental Impact Assessment notification, 2006.

And whereas, keeping inter-alia in view the foregoing, the Ministry of Environment and Forests has decided to accept the aforesaid recommendations of the High Level Committee constituted vide OM No.21-270/2008-IA.III, dated the 11th December 2012;

Now, therefore in exercise of the powers conferred by sub-section (1) and clause (v) of sub-section (2) of section 3 of the Environment (Protection) Act, 1986 (29 of 1986) read with sub-rule (4) of rule (5) of the Environment (Protection) Rules, 1986, the Central Government hereby makes the following further amendment to the notification of the Government of India, in the Ministry of Environment and Forests number S.O. 1533(E), dated the 14th September, 2006 after having dispensed with the requirement of notice under clause (a) of sub-rule (3) of the said rule 5 in public interest, namely:—

2. In the said notification, —

(a) in paragraph 7, in sub-paragraph II, for item (i), the following item shall be substituted, namely:

(i) "Scoping" refers to the process by which the Expert Appraisal Committee in the case of Category A projects activities, and State level Expert Appraisal Committee in the case of Category 'B1' projects or activities, including applications for expansion or modernization or change in product mix of existing projects or activities, determine detailed and comprehensive Terms of Reference (TOR) addressing all relevant environmental concerns for the preparation of an Environment Impact Assessment (EIA) Report in respect of the project or activity for which prior environmental clearance is sought and the Expert Appraisal Committee or State level Expert Appraisal Committee concerned shall determine the terms of reference on the basis of the information furnished in the prescribed application Form 1 or Form 1A including terms of reference proposed by the applicant, a site visit by a sub-group of Expert Appraisal Committee or State level Expert Appraisal Committee concerned only if considered necessary by the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned, terms of Reference suggested by the applicant if furnished and other information that may be available with the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned;

Provided that the following shall not require Scoping—

- (i) all projects and activities listed as Category 'B' in item 8 of the Schedule (Construction or Township or Commercial Complexes or Housing);
- (ii) all Highway expansion projects covered under entry (ii) of column (3) and column (4) under sub-item (f) of item 7 of the Schedule;

Provided further that—

- A. the projects and activities referred to in clause (i) shall be appraised on the basis of Form I or Form 1A and the conceptual plan;
- B. The projects referred to in clause (ii) shall prepare EIA and EMP report on the basis of model TOR specified by Ministry of Environment and Forests;

(b) in the Schedule, against sub-item (f) of item 7, in column (3), for the entry (ii), the following entry shall be substituted, namely:—

- "(ii) Expansion of National Highways greater than 100 km involving additional right of way or land acquisition greater than 40m on existing alignments and 60m on re-alignments or by-passes."

Subject: Plantation Strategy for land parcel given for Compensatory Plantation in Yamuna Floodplains

This is with reference to land transferred/ handed over to the Forest Department for the purpose of Compensatory Plantation done by Forest Department on behalf of National Highways Authority of India (NHAI) in lieu of felling of 1952 trees for 8 laning of section of NH-1 from Mukarba Chowk to Panipat. Approx. 19.52 Hectares of land was transferred in Yamuna Floodplains between Yamuna Bank Metro Station and Railway Line adjacent to CWG Village Complex.

The area under reference falls within the river floodplains and hence plantation in this area shall be done in accordance with the recommendations of Hon'ble NGT. The plantation strategy shall be in accordance to the riverine ecosystem function of the floodplains.

The suggestive plantation is divided into four different zones based on the topographical study i.e. Elevation levels of the site.

- The Riparian plantation is along the river edge, wetland system and river basin community which is at the lowest level.
- The River Basin community is along the Greenway, which lies at the highest elevation level
- The Outer fringe zone and floodplain forest lie between the riparian and river basin community.

The planting scheme may be got approved from the Landscape Department of DDA.


